NCRA are to object to Chas Storer's application for the building that is much larger footprint than previous which was not in line with the National Planning Policy and within the green belt. Licence applications were discussed for Cuffley Café where they are applying for

an alcohol licence and extending their hours. There was also an application by a warehouse in Sopers Road for a music licence which includes playing recorded music outside and live music inside 7 days a week. NCRA will object to this as it is very close to residential properties.

The Licence Hearing for Music Festivals at Park Farm takes place on 15 July 2021.

It was also mentioned that the Local Plan for Enfield was proposing 3000 homes for Crews Hill and a further 3000 homes in Hadley Road.
